RMCAD offers an Art Education, BFA degree program that is approved by the Colorado Department of Education and Colorado Department of Higher Education for initial K-12 teacher licensure in visual arts in the state of Colorado. Many students intend to pursue teacher licensure or certification in states other than Colorado. Licensing requirements vary from state to state and are subject to change at any time and without prior notice to RMCAD.
